You may register your residential telephone number, including any wireless numbers, on the national Do-Not-Call Registry at no cost, either by telephone or via the Internet. To register by telephone, call **1-888-382-1222**. For TTY, call 1-866-290-4236. You must call from the number you wish to register. You may register, or obtain additional information, via the Internet at www.donotcall.gov. Three months after your registration, your number will be registered and will remain on the Do-Not-Call Registry for five years.
